

# Information and Consent

Invisalign® treatment outcomes and treatment timelines are dependent on the quality of the product from Align Technology (2 million cases, 97% patient satisfaction), the experience of your dentist in working with Invisalign®, and your level of participation in this process. We need your permission to be able to use all the components of the Invisalign® system, as well as your commitment to full time wearing of the aligners.

## Attachments

For certain types of movements to be achieved, aligners need assistance in maintaining their grip on a tooth and therefore their ability to get the desired tooth movement. To accomplish this, Align Technology custom designs small tooth-coloured “bumps” that are temporarily and precisely bonded to some teeth to improve the effectiveness of the aligners. A small bubble in your aligner will correspond precisely to each of these attachments.

These attachments are visible but not too noticeable from conversation distance. They may be more noticeable on the upper front teeth but that is also where we want the highest level of finish detail, and hence the possible need to use them here.

## IPR

Interproximal Reduction (IPR) is filing between your teeth to create up to a quarter of a millimetre of space per tooth surface. Since this is the thickness of a few pieces of paper, it is generally not even noticeable. The filing is usually done with a thin strip of metal that has fine diamond particles embedded on one side. Dentists also use these strips to polish fillings between teeth so it is a process that you may have already experienced. It is similar to using dental floss or dental tape between your teeth.

IPR is very valuable because:

- A small amount of IPR on a number of teeth can create the space needed to correct crowding without extracting any teeth.
- IPR reduces friction between tight teeth, facilitating movement.
- IPR can render better tooth shape and broader contact between teeth. This may be more stable, more aesthetic and may result in improved gingival and periodontal health.
- IPR may be a successful alternative to extracting teeth to create space to realign your teeth.

### Your Commitment to Wearing your Aligners

Tooth movement is a biological process stimulated by very light force (200 grams). However, efficient tooth movement requires that the light force be as continuous as possible. We have learned from our patients that full time wear (22 hours per day) is more effective than episodic wear. There are several reasons for this:

- When you wear aligners all the time, you get used to them – they become your new ‘normal’ feel in your mouth
- When aligners are worn full time, the bite changes temporarily as the teeth are moved. Therefore, when you don’t have the aligner in place in your mouth, your teeth will feel strange when they bite together and may not contact together as you would have expected. So it is more comfortable with aligners in than out.
- Part time wear means that the aligners are not working as effectively.

### Refinement

At the end of treatment, we may order further aligners for ensuring that the outcome with your smile is as close to being perfect as possible. With a "Full Invisalign® case", there are three refinements available for free if ordered within 6 months of finishing the initial treatment. With a "Lite Invisalign® case", only one auto-refinement, of up to 14 aligners, is available. With an "Invisalign i7 case, only one auto-refinement, of up to 7 aligners is available.

I understand there is a charge for additional sets of aligners ordered after my treatment has been completed and that there is a time limit for ordering more aligners.

### Retention

At the end of the treatment, we recommend the use of retainers or else the teeth will shift and move back to the original position. We recommend "VIVERA RETAINERS" which can be purchased at an extra cost. They are a set of three retainers for each arch and every retainer has to be worn for 4-6 months.

I understand, teeth can shift if retainers are not used enough to keep them fitting and that there are charges for extra retainers and for treating relapse.
